**RESOLUTION 2007-02-28
 REGARDING TRIBAL ORGANIZATION**

WHEREAS; THE MEMBERS OF THE TRIBAL COUNCIL (COUNCIL) CONVENED ON FEBRUARY 28, 2007 TO EVALUATE THE BIA DIRECTIVE OF FEBRUARY 23, 2007 WHICH PERTAINS TO THE ORGANIZATION OF THE TRIBE AND THE SETTING OF AN INITIAL MEETING BETWEEN YAKIMA DIXIE AND SILVIA BURLEY; AND

WHEREAS; THE COUNCIL ASSUMES THAT THE OLSEN DETERMINATION/DIRECTIVE OF FEBRUARY 11, 2005 IS THE PLATFORM FOR TRIBAL ORGANIZATION, WHEREIN HE STATES: "THE FIRST STEP IN ORGANIZING THE TRIBE IS IDENTIFYING PUTATIVE TRIBAL MEMBERS."; AND

WHEREAS; THE COUNCIL WISHES TO REAFFIRM THE PUTATIVE MEMBERS AND THE CRITERIA FOR DENOMINATING SUCH MEMBERS AS THEY WERE SUBMITTED TO THE BIA IN THE CONSTITUTION OF FEBRUARY 19, 2006, PART 6.

THEREFORE BE IT RESOLVED, THAT THE TRIBAL COUNCIL HEREBY APPROVES OF THE FORTH-COMING MEETING AS PROPOSED BY THE BIA IN ITS LETTER OF FEBRUARY 23, 2007 AND URGES THE BUREAU TO PROCEED AGGRESSIVELY WITH THE ORGANIZATION OF THE TRIBE. IN ADDITION, THE COUNCIL REQUESTS THAT THE BIA RECOGNIZE THE TRIBAL HEADQUARTERS AS BEING AT 11178 SHEEP RANCH RD.; SHEEP RANCH, CALIFORNIA 95250 AND THE ORGANIZING PUTATIVE MEMBERS AS BEING THOSE WHO WERE IDENTIFIED IN THE FEBRUARY 19, 2006 CONSTITUTION.
