**PUBLIC NOTICE**

**TO: ALL FEDERALLY-RECOGNIZED ENROLLED MEMBERS OF THE CALIFORNIA VALLEY MIWOK TRIBE**

**Special Meeting of the General Council  
Of the California Valley Miwok Tribe  
January 7, 2010 at 10:00 am**

In correspondence dated December 22, 2010, the Assistant Secretary of Indian Affairs at the United States Department of Interior rescinded previous letters from the Bureau of Indian Affairs ("BIA"), which challenged the authority, leadership and organizational status of the Tribe. Therefore, the California Valley Miwok Tribe ("Tribe"), acting as an organized entity, wishes to take action to bring the highly contentious period of the Tribe's history to a close. The Assistant Secretary's recent decision also rescinded the BIA letter, dated March 26, 2004, which indicated that Sylvia Burley was "merely a 'person of authority' within the Tribe." Therefore, consistent with previous actions taken by the Tribe, the Tribe presently recognizes Sylvia Burley as its Chairperson.

In accordance with the General Council Resolution #GC-98-01, special meetings of the General Council may be called, upon providing requisite notice (15 days) and elaborating the purpose of the meeting.

Pursuant to General Council Resolution #GC-98-01 and reaffirmed in a recent decision of the Assistant Secretary of Indian Affairs at the United States Department of Interior, dated December 22, 2010, the General Council is the governing body of the Tribe, comprised of four (4) adult federally recognized members: **Sylvia Burley; Yakima Dixie; Anjelica Paulk; and Rashel Reznor.**

Further, pursuant to General Council Resolution #GC-98-01, the General Council "shall appoint from among its members a Chairperson, who shall preside over all meetings of the General Council and rights and powers through subsequent resolutions of the General Council..." as well as a Secretary/Treasurer, "who shall record the minutes of all General Council meetings, maintain the official records of the Tribe, certify the enactment of all resolutions, and disburse all funds as ordered by the General Council."

Therefore, the purpose of the special General Council meeting shall be for the governing body of the Tribe, the four (4) enrolled adult members referenced above, to elect Tribal Officers, including but not limited to a Chairperson and a Secretary/Treasurer, pursuant to General Council Resolution #GC-98-01, to assist in administering the daily governmental affairs/operations of the Tribe.

The purpose of the special General Council meeting shall not be to pursue any efforts to formally organize the Tribe, as all necessary actions for formal organization have previously taken place, pursuant to General Council Resolution #GC-98-01, and such actions have been verified as sufficient for the Tribe's formal organization in the recent decision of the Assistant Secretary of Indian Affairs at the United States Department of Interior, dated December 22, 2010.

In accordance with General Council Resolution #GC-98-01, this document serves as the required fifteen (15) day public notice.
